Personal Information we process:

Gimatex processes your personal data when you use our services and/or when you provide them to us.

Below is an overview of the personal data we process:

- Given and family name
- Phone number
- Email
- Information about your activities on our website
- Internet Browser and device type

Special and/or sensitive personal data that we process:

Our website and/or service does not intend to collect data about website visitors who are under the age of 16 years. Unless they have permission from a parent or guardian. However, we cannot check if a visitor over the age of 16. We therefore recommend parents to be involved in the online activities of their children, so that no data on children will be collected without parental consent. If you're convinced that we have collected personal information of a minor without consent, please contact us via info@wirefencing.nl, then we will delete this information.

For what purpose and on what basis we handle personal data

Gimatex processes your personal data for the following purposes:

- we will be able to call or email you if necessary for our services or performance
- we analyze your behavior on the website, improving our website to align to your preferences.

How long do we keep personal

Gimatex keeps your personal information no longer than strictly necessary to achieve goals wherefor we collected your data.

Sharing personal data with third parties

Gimatex does not sell your information to any third party and will share this only if it is necessary for the implementation of our agreement with you, or to meet a legal obligation. With companies that will process your data on our behalf, we close a processing agreement to provide the same level of security and confidentiality of your data. Gimatex remains responsible for this processing.

Cookies, or other techniques that we use

Gimatex uses technical, functional and analytical cookies that do not infringe on your privacy. A cookie is a small text file that will be stored on your computer, tablet or smartphone with the first visit to this website. The cookies we use are necessary for the technical operation of the website and ease of use. They make sure that the website is functioning properly and remember for instance your preferences. We can also use this to optimize our website. You can opt out of cookies through your Internet browser. You can also remove all information previously stored via your browser settings.

Data view, modify or delete

You have the right to see, correct or delete your personal information. In addition, you are entitled to withdraw or to oppose the processing of your personal data by Gimatex and you have the right to data portability. That means that you can request to submit the personal information we have and send it via a computer file to you or an organization you mentioned.

You can request to access, correct, delete or transmission data from you or request to withdraw your consent to the processing by sending your personal data to info@wirefencing.nl.

To ensure that the access request is made by you, we ask you to send a copy of your identification with the request. Make this copy of your passport, MRZ (machine readable zone, the strip with numbers underneath the passport), passport number and Social Security Number (SSN) made anonymous. This is to protect your privacy. We will respond as soon as possible but within four weeks, at your request.

Gimatex also wants to point out that you have the possibility to file a complaint at the national regulator, the Authority for Personal Data. That can be done via the following link:
